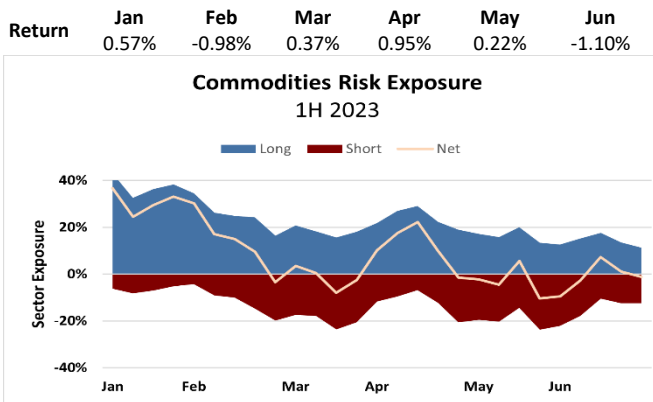

The Grant Park Multi Alternative Strategies Fund (GPAIX) delivered positive returns in Q2 of +2.72% bringing year-to-date performance to +1.73%. Positive returns generated in Equities, Currencies and Commodities were slightly offset by small losses in Fixed Income for the quarter.

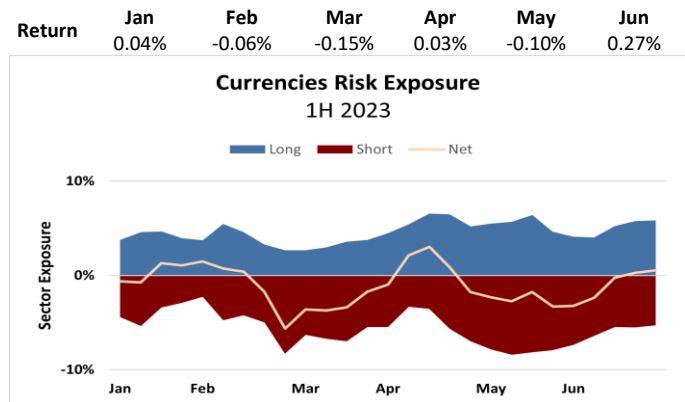
Throughout the quarter, stock and bond markets continued to follow inflation-related headlines. Stocks rallied into quarter-end on the Fed pause and easing inflation concerns. Bonds sold off in the quarter due to mixed indicator signals and continued higher inflation globally. Accommodative policies by the Bank of Japan benefited the Fund’s positions in Japanese Government Bonds, the Nikkei Index and the Yen. The Fund also captured profitable gains in Sugar and Cocoa throughout the quarter due to weather-related supply concerns.

Risk Exposure by Sector

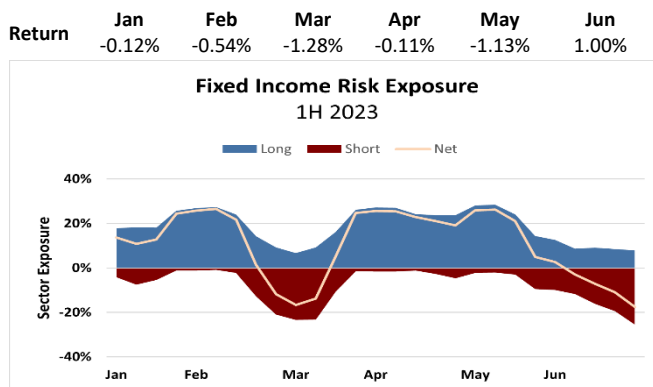

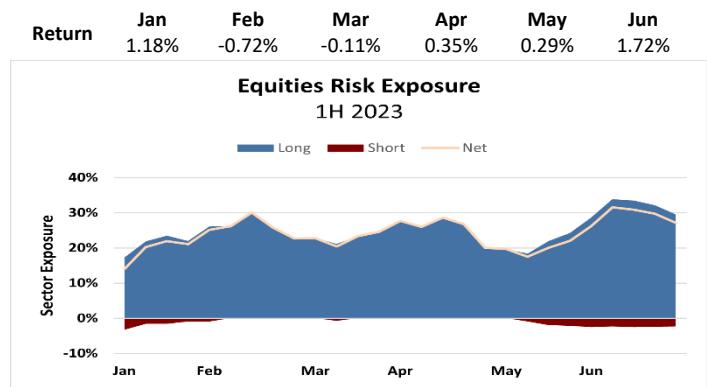

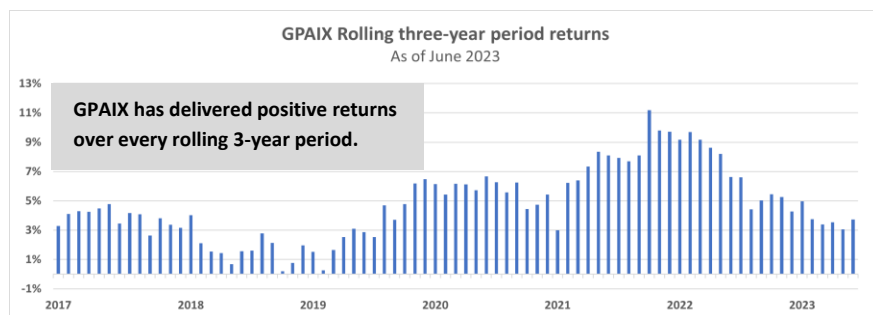

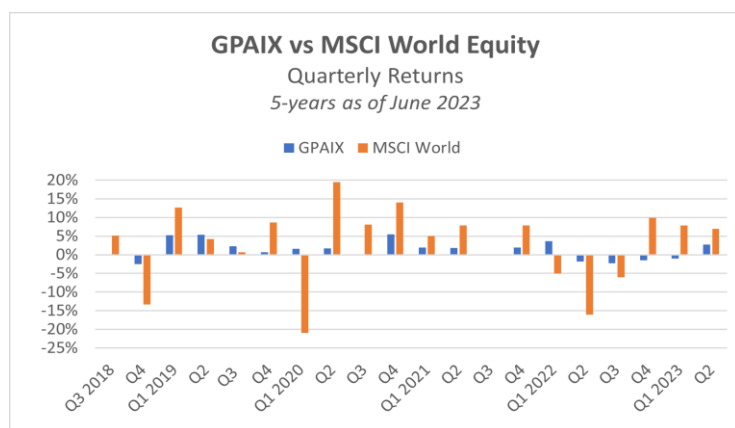
Historical positive returns and diversification

Portfolio Diversification

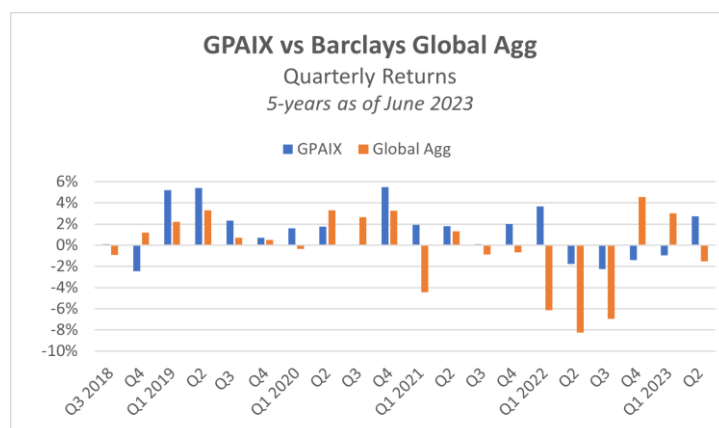
Historically, GPAIX has provided diversification and reduced portfolio volatility.

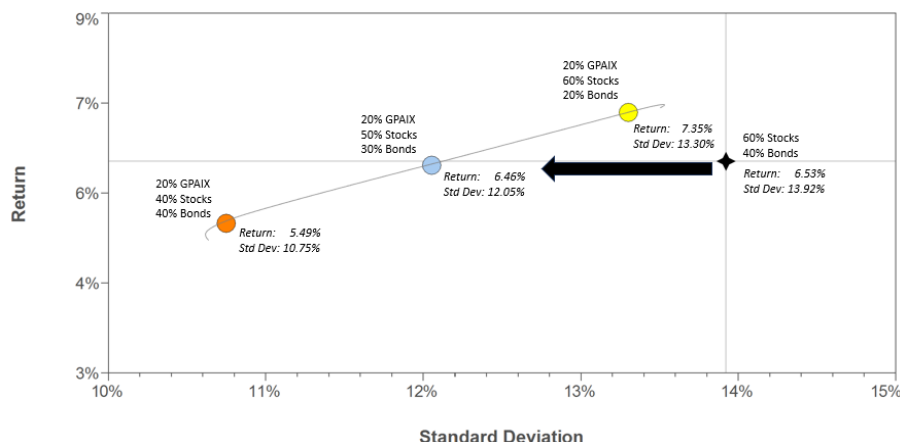

Glossary

Standard Deviation: A measure of investment risk that examines the variation of returns around the mean return. Higher volatility equates to higher standard deviation.

Correlation: A statistical measure of the degree to which two securities move in relation to each other. Correlations are computed as the correlation coefficient, which has a value that must fall between -1.0 and +1.0

MSCI World Equity Index: Represents performance of the full opportunity set of large- and mid-cap stocks across 23 developed and 26 emerging markets.

Bloomberg Barclays Global Aggregate Index: Measures global investment grade debt from twenty four local currency markets. This multi-currency benchmark includes treasury, government-related, corporate and securitized fixed-rate bonds from both developed and emerging markets issuers.

Sharpe Ratio: (Average Return-Risk Free Return)/Standard Deviation of Return. The ratio measures the relationship of reward to risk in an investment strategy.

Beta: is a measure of the volatility or systematic risk of a security compared to the market as a whole
